Amendements to...

WHAT'S NEW?

BS7593 (the 'Code of practice for the preparation, commissioning and maintenance of domestic central heating and cooling water systems') is being incorporated into Part L of the Building Regulations. This amendment transforms BS7593 from an advisory document to one that is now mandated - its points must now be adhered to.

THE MAIN CHANGES

1. Installation of in-line filter required

A filter to protect system components now needs to be installed, complementing a chemical clean and flush. Sentinel filters like the Vortex300 and Vortex500, or Vortex250, can be used.







2. Annual checks for concentration of chemicals and water cleanliness

Keep on top of inhibitor levels! The presence of inhibitor to protect systems must be checked each year. We offer simple and easy tests like the X100 QuickTest, which allows confirmation of inhibitor presence within minutes.



3. Inhibitor to be re-dosed at 5 year intervals

Whilst X100 will give lifetime protection, the amendments state that a system should be cleaned, fully drained and refreshed every 5 years, adding new inhibitor.





4. Biocidal and frost protection to be used where applicable

Across low temperature installations, fungal growth is to be kept at bay using a biocide like X700 and for systems liable to freezing, an inhibited antifreeze, such as X500, needs to be used.





- 5. There are only 3 recommended cleaning methodologies:
 - · Powerflushing (external pump and tank)
 - · Mains pressure
 - Gravity cleaning

 $Ensure\ your\ powerflush\ is\ compliant.\ An\ `external\ pump\ and\ tank$ arrangement' is required, otherwise the procedure does not meet the criteria, for example flushing using magnet technology, does not fit the bill. A powerflushing machine like the JetFlush Rapid is the perfect machine to tick all of the boxes for any powerflushing job.
